Nominations for the 14th Legal Aid Practitioners Group Legal Aid Lawyer of the Year awards officially open today (1 March).

New for 2016: introduction of crowdfunded sponsorship for popular Legal Aid Newcomer Award; eligibility criteria extended to include lawyers in Northern Ireland.

Nomination period ends 25 April; winners to be announced 7 July in central London.

Nominations for the 2016 Legal Aid Lawyer of the Year (LALY) awards are now open. There are 12 awards in total including Children's Rights, Public Law, Family Legal Aid, Mental Health, and Criminal Defence (see full list, below).
