Stage 1 applicants have a final chance to join the October 2025 Duty Rotas. Compliant verification information must be submitted by 31 March 2025.

In February 2025, the LAA advised all applicants in Stage 1 of the Crime Contract tender process that they wanted to give as many applicants as possible the opportunity to join the October 2025 Duty Rotas. In order to do so they would continue to review verification information submitted after the 31 January deadline.

#### <u>Civil means: New LAA process for requesting further information on business</u> cases

Following a successful pilot, the LAA has introduced a new process for all civil providers for requesting further information from clients starting from 1 March. This new process allows clients to have an LAA means caseworker request the further information directly from them via email, rather than through their solicitor.

From the pilot, the LAA say that they learned that providers need the most help with business cases. Therefore, this new process is currently being introduced for business cases only. This includes applications where the client is self-employed, in a business partnership, a company director, or owns shares in a company.

#### LAA Provider survey on capacity and demand

The LAA is launching a provider survey on 31 March 2025 in an effort to understand capacity and demand in the legal aid sector. They sent out the following message on 26 March, which will be followed up with the survey itself to a randomly selected group of legal aid providers.

If you are on that list, we encourage you to participate in this survey. For many years we have been pushing the MoJ and LAA to gain a greater understanding of the sector's capacity to respond to the needs of eligible legal aid clients. As the message below suggests, we were consulted by the LAA on the questions posed in the survey. The LAA only took on board some of our suggestions, and there are some issues with the survey as a result, but it is still a useful first step in gathering a better understanding of how and why the legal aid scheme undermines your ability to help more clients.

Dear Legal aid provider,

Your Voice Matters: help us improve our understanding of legal aid capacity and demand by sharing your knowledge and experience. Your valuable insights will strengthen legal aid and shape the future of legal aid delivery.

The Legal Aid Agency (LAA) is launching a survey to providers who currently hold contracts with us. The survey will launch on 31 March 2025, to approximately 20 percent of providers who hold a legal aid contract, encompassing a random selection from all categories of law, and will **close on 12 May 2025.** We aim to launch the survey to the remainder of our providers later this year.

In line with recommendations from the National Audit Office (NAO) and the Public Accounts Committee (PAC) 2024 reports, this survey will enable the Ministry of Justice and the LAA to gain a more detailed understanding of market capacity and demand for legal aid services. It will also highlight current challenges in how we work with our providers.

#### <u>LAPG research project - non-chargeable time in legal aid work - </u> PARTICIPANTS NEEDED

We are still on the look-out for participants for our non-chargeable time research project. Many of you will have seen that we used preliminary findings, provided by Dr Jo Wilding, from this project in our civil fees consultation response. We know that the MOJ and LAA are very interested in the issues that our initial efforts have highlighted, such as the sheer amount of free work that they are getting out of practitioners and support and management staff.

We have a number of organisations engaged in the current data collection phase of the project, time recording using the research tool we have developed. However, to make a compelling case to government, backed up by robust data, we would like to recruit a larger pool of participants across the sector for this important piece of work.

We are reliably informed by participants in the pilot phase of the project that the time it takes to complete the time recording spreadsheet we have developed, is between 5-10 minutes per day so not onerous.

The overarching aim of the project is to compile robust empirical data on hidden or 'non-chargeable' costs of doing legal aid work, in order to influence policy in relation to legal aid funding and the operation of the scheme.

We launched this project in response to providers voicing their concerns about the ever increasing burden of non-chargeable time involved in legal aid work.

We have three research objectives:

2. Analyse what tasks are intrinsically linked to the proper management of casework but are not currently claimable time in the Cost Assessment Guidance and Criminal Bills Assessment Manual.

3. Evaluate the complexity of the funding scheme and contractual framework and identify elements that may create complexity without adequate justification. This may include identifying duplication of tasks required by legal aid contracts and regulatory or quality assurance requirements.
