Civil Legal Aid News

Means testing guidance update

Following the recent changes to dependants allowances, state benefits and tax rates for 2025/26, the LAA has amended their civil Means Assessment Guidance and published an updated civil means keycard (#61) which you can find here.

Working with the LAA - provider guidance

The LAA has produced <u>a useful set of guidance</u> on working with them for new and existing civil legal aid providers. It covers various aspects of how to manage your legal aid contract including links to all LAA guidance in one handy document including: CWA, getting started for new providers (which might also be a useful refresh for existing providers), means testing, merits testing, exceptional and complex cases, exceptional case funding, high cost family, civil billing for providers and counsel, and other links to useful general guidance.

It is certainly worth <u>circulating this document</u> amongst legal aid colleagues (the document is not currently available on the LAA training website but will appear at

some point soon).

Signing up to the new Apply for Civil Legal Aid service

Another quick reminder to sign up to use the new Apply for Civil Legal Aid service to:

- Apply for Domestic Abuse (except for Domestic Abuse protection orders),
 Section 8 and Special Children Act proceedings
- Apply for passported and non-passported clients (in the above cases only)
- Submit new applications (you will need to manage live cases using CCMS) (in the above cases only)
- Make emergency applications if using delegated functions (above cases only)

The LAA is keen to get as many providers onto the new service as possible and it does appear to be user-friendly and save time. It is currently only available for the areas listed above, but will eventually be rolled out across all categories of civil legal aid.

If you would like to on-board for 'Apply for civil legal aid', email:

The LAA will then take you through the on-boarding process and get you started. They will ask you to provide the CCMS usernames and email addresses of all users you would like to on-board.

Civil fixer emails

And another reminder to our members to use the LAA fixer services: the Application Fixer, Civil Claim Fix, and High-Cost Family Fixer emails are all now available and really do save time. These services were developed by the LAA in response to complaints from providers that there was/is a 'culture of refusal' at the LAA when making decisions on whether to grant legal aid or pay for cases.

All three services aim to help the LAA to issue certificates or pay bills more quickly.

Notifying the media about reporting restriction applications

HMCTS have asked us to share this update regarding notifying the media about reporting restriction applications.

Under Criminal Procedure Rule Part 6, legal professionals are responsible for notifying media representatives when applying for discretionary Reporting Restriction Orders.

HMCTS has put in place Media Distribution Lists at all Crown Courts, which contain the names of approved journalists and publications who have consented to their email addresses being shared with those applying for reporting restrictions.

When applying for a discretionary Reporting Restriction Order, please contact the admin office at the relevant Crown Court who will provide you with the local Media Distribution List. You should then send those media representatives your application in advance of hearings.

This will ensure that the media are given the opportunity to consider issues, take instructions and prepare representations, as part of upholding the principle of open justice.

Cross-Cutting Legal Aid News

Means Test Review changes

If, like us, you are wondering what has happened to the <u>MoJ's promised means</u> test review changes, following the <u>outcome of the consultation published in May 2023</u>, we can share the following update provided at a recent Civil Contract Consultative Group meeting in response to our request for a timetable for implementation.

'In light of the ongoing Spending Review, Ministers are currently considering their preferred approach to the rules and arrangements governing legal aid financial eligibility. We will update the sector on this as soon as we are able.'

We are now almost two years on from the promised changes which were planned in four stages:

- 1. Non-means tested areas of civil legal aid
- 2. Civil means test and contributory system
- 3. New criminal legal aid means test
- 4. Removal of Crown Court capital passporting for benefits recipients who are

homeowners

Currently, only stage 1 has been implemented. We were previously told by the MoJ that they expect all four stages to be complete by Summer 2026, three years after the conclusion of the consultation.

The thresholds are due to be reviewed every three years, and it seems likely that by the time the first three-year deadline has arrived (May 2026), the thresholds will still not have been uprated. We are assuming that there will not be a further uprating of thresholds undertaken before the changes come in, so they will already be in need of review.

As to the why there has been so little progress, we are told that this is because of the complex nature of the changes and the sheer scale of digital change required across several different LAA systems. This demands a fully integrated approach with rigorous testing of the new systems before they can go live. All of this has to be achieved whilst maintaining the functionality of the existing schemes so that applications can continue to be assessed and processed without adversely affecting clients and providers.

<u>LAPG research project - non-chargeable time in legal aid work - PARTICIPANTS NEEDED</u>

We are still on the look-out for participants for our non-chargeable time research project. Many of you will have seen that we used preliminary findings, provided by Dr Jo Wilding, from this project in <u>our civil fees consultation response</u>. We know that the MOJ and LAA are very interested in the issues that our initial efforts have highlighted, such as the sheer amount of free work that they are getting out of practitioners and support and management staff.

We have a number of organisations engaged in the current data collection phase of the project, time recording using the research tool we have developed. However, to make a compelling case to government, backed up by robust data, we would like to recruit a larger pool of participants across the sector for this important piece of work.

We are reliably informed by participants in the pilot phase of the project that the time it takes to complete the time recording spreadsheet we have developed, is between 5-10 minutes per day so not onerous.

The overarching aim of the project is to compile robust empirical data on hidden or 'non-chargeable' costs of doing legal aid work, in order to influence policy in relation to legal aid funding and the operation of the scheme.

We launched this project in response to providers voicing their concerns about the ever increasing burden of non-chargeable time involved in legal aid work.

We have three research objectives:

- 1. Identify and quantify 'hidden' but unavoidable costs associated with legal aid contracts.
- 2. Analyse what tasks are intrinsically linked to the proper management of casework but are not currently claimable time in the Cost Assessment Guidance and Criminal Bills Assessment Manual.

3. Evaluate the complexity of the funding scheme and contractual framework and identify elements that may create complexity without adequate justification. This may include identifying duplication of tasks required by legal aid contracts and regulatory or quality assurance requirements.
