<u>Crime consultation - Criminal Legal Aid: Proposals for Solicitor Fee Scheme</u> <u>Reform</u>

On 9th May 2025, the Government published a consultation on proposed changes to the criminal legal aid fee schemes, including prison law. The consultation is due to run for eight weeks and closes on the 4th of July 2025.

The announcement with <u>summary details is here</u>, whilst the consultation itself is <u>hosted separately here</u>.

The consultation follows the announcement in December 2024 that the Government intended to invest up to £92 million per year more in funding for criminal legal aid fees. The consultation seeks views on uplifting fees in most criminal legal aid fee schemes, meaning work in police stations, magistrates' courts, the Crown Court, and prison law work.

We have provided a brief summary below of each proposal:

Police Station Fee Scheme

The proposal is to fully harmonise police station fees by uplifting all schemes to a fixed fee of £320 excluding VAT. The proposal delivers an increase to all fees in the police station scheme, including the highest paid fee scheme which is Heathrow at £316.86 excluding VAT. The escape fee threshold will increase to £960 excluding VAT.

Magistrates Court

The proposal is a 10% uplift on all fees for magistrates' court and youth court work.

Litigators' Graduated Fee Scheme

The consultation proposes two amendments to the LGFS:

- A fixed ratio between outcomes The proposal is to implement a fixed ratio of 65:75:100 for basic fees in the LGFS.
- Uplifting the lowest paid basic fees The proposal is to raise the trial basic fee for Offence Types E, F, G, H, and I by around one third.

Prison Law

The proposal is to increase prison law fees by 24%.

Over the coming weeks we'll be consulting LAPG's Advisory Committee to help us prepare our consultation response. We will also be discussing the proposals with our partner organisations such as The Law Society, Association of Prison Lawyers, CLSA and LCCSA. CCMS Outage this weekend

The LAA issued the following announcement yesterday about access to CCMS:

'In order to continue to bolster the security of our systems we will be taking the Portal offline over the weekend **from Friday**, **16 May at 21:00 to Monday**, **19 May at 06:00**. As confirmed in Lucy Jones' message of 13 May, whilst we continue with this programme of work we will be taking Portal offline each weekday evening from 9pm to 6am until further notice. We will continue to keep you updated as to any changes of system availability. We apologise for any inconvenience caused by the ongoing works.'

2024 Standard Civil Contract Extension

The LAA <u>announced this week</u> that the current Civil Contract will be extended to 30 June 2027:

'Next steps

There is no action needed for existing 2024 Standard Civil Contract holders. Contract schedules will be updated in due course.

Why is this happening?

The LAA is committed to the provision of Civil Legal Aid and the provision of certainty to the market that encourages wider growth.

This is part of the LAA's ongoing commitment to do all we can to enable suitably qualified providers to offer legal aid funded services. It offers the ability for existing providers to expand their services as well as encouraging new providers to join.
