Prison law escape fee guidance

The LAA has now updated its guidance on what is required in these cases by way of supporting evidence. <u>The news story is here which includes</u> <u>links to the CRM18A form and the guidance</u>.

Submit the following along with your CRM18A form:

The time ledger and key documents including:

- all file notes
- detailed attendance notes
- page counts of documents considered
- copies of any documents drafted
- page counts of Parole Dossier (original documents are not required where page
- counts have been provided)
- letters and calls copies of these are required (where quantities are excessive a detailed ledger with dates and explanation will suffice)
- original completed CRM1 and CRM2 forms if your claim includes any freestanding advice or assistance
- original invoices for disbursements exceeding £20
- original CRM11 form (optional)

<u>The Law Society issues press release about</u> <u>criminal legal aid funding</u>



The Law Society has issued a press release criticising the lack of government action on reforming criminal legal aid funding since the outcome of the partially successful judicial review in January 2024.

The release notes:

'Since the judgment, the government has failed to deliver results despite the Lord Chancellor being on record saying "some extremely trenchant, sobering and striking remarks were made by the court [in response to the judicial review], which I have read carefully and very much taken on board".

Law Society president Nick Emmerson said:

"Four months on from our High Court victory, the government's failure to act quickly on the ruling, in spite of the strong evidence submitted by us, has meant that time has now run out. The urgent investment needed in criminal legal aid has effectively been kicked into the long grass.

"Despite the Lord Chancellor's commitment to accelerate the necessary decisions, which he made in good faith to us, the timetable of a general election has left our members without the money they urgently need for many more months.""

Digital developments in applying for criminal legal aid

The LAA's current service contract that supports processing of applications and claims on criminal legal aid (eForms) ends in September 2024. They are developing new digital replacement in-house services to replace the current CRM forms when the eForms contract ends in September.

Forms to be replaced are:

- Apply for criminal legal aid (CRM14 and 15)
- Claim a non-standard magistrates' court payment (CRM7)
- Apply for prior authority to incur disbursements (CRM4)
- Apply for extension of upper limits (CRM5)
- Accessing historic eForms information

Providers will no longer be able to submit eForms on Equiniti from Tuesday 6 August 2024. The LAA will continue to process claims that are currently within the e-forms service until Tuesday 20 August to ensure any pending eForms are processed.

How to receive your representation order

The LAA has said that when submitting an application, use the free text box on the 'Do you need to add any more information to this application?' page to confirm the email address to which Representation Orders should be sent. If no email address is supplied, they will automatically send Representation Orders to the user account email on record in CWA.

From Monday 3 June 2024, all calls regarding Magistrates' Billing will be handled by the LAA's Crime Customer Services Team (CST). The LAA has said that this change is aimed at streamlining their communication process and providing you with a more efficient and cohesive customer experience.

Frontier Economics report on legal aid sustainability

The Law Society has published its <u>final report with</u> <u>economic consultants Frontier Economics</u> on the sustainability of civil legal aid.

Following on from its interim report which was published in March this year, the report took a



deep-dive look at Housing and Family providers. The research engaged with over 45 legal aid providers and secured 47 financial returns, with 30 pertaining to housing and 17 to family legal aid. An overwhelming 82% of the 45 engaged providers experienced losses in their overall civil legal aid endeavours, and all not-for-profit providers are loss-making. The findings emphasise the need for targeted support and reforms to ensure the continued viability of civil legal aid services.

The headlines findings are:

- Civil legal aid work is loss-making for the majority of housing and family legal aid providers sampled (82%)
- All housing legal aid providers in the sample were loss-making from their civil legal aid work, including all private sector solicitors offering housing legal aid
- 47% of providers sampled working in family legal aid were also loss making
- All not-for-profit providers sampled in both areas of law were making a loss

The report provides another useful data-set for influencing the Review of Civil Legal Aid (RoCLA), which was due to conclude with the publication in July of a Green Paper setting out future plans for civil legal aid reform. The MoJ has told us that RoCLA is currently on hold pending the outcome of the general election.

Public Accounts Committee publishes Value for Money from Legal Aid report

The PAC has published its report assessing the MOJ's ability to demonstrate the value for money

of legal aid spend and the impact of legal aid reforms such as the introduction of LASPO.

From the PAC website:

The report finds that, nearly a decade on from the PAC's last report on the subject, the Ministry of Justice still lacks an understanding of the costs and benefits of its 2013 legal aid reforms and whether those who are eligible for legal aid can access it.

The PAC expresses its deep concerns in the report about MoJ's and the Legal Aid Agency's lack of curiosity on the impact of decreasing numbers of providers on people's access to legal aid, despite evidence which suggests access is getting more difficult.

The report makes a number of very telling recommendations:

Recommendation 1: In its Treasury Minute response, the Ministry of Justice and the Legal Aid Agency should set out how they intend to improve the data they collect on demand for and access to legal aid so that they can better monitor:

- whether an area has sufficient provision for a particular category of law to meet demand. This should include details of how they plan to consider specific local variation such as deprivation or access to public transport and demographics such as disability; and
- the extent to which capacity constraints may mean people are unable to access legal aid in areas where there are providers.

Recommendation 2: In its Treasury Minute response, the Ministry of Justice should:

- clarify what the options are for those who are unable to make use of remote advice. It should specifically consider vulnerable groups in areas with no face-to-face legal aid provision, whose issues may be too complex to solve via telephone; and
- set out how it plans to better understand the impact of remote provision on vulnerable groups and address any problems identified.

Recommendation 3: The Ministry of Justice should set out in its Treasury Minute response:

• how it plans to monitor the impact of the Illegal Migration Act 2023 on the capacity of

other areas of immigration advice and how it plans to respond where evidence suggests people are unable to access advice; and

• details of its plans to assess whether the Exceptional Case Funding scheme is the most efficient route for immigration cases.

Recommendation 4: In its Treasury Minute response, the Ministry of Justice should set out what it will do to:

- ensure that financial eligibility thresholds for legal aid are kept under review in light of changes in the economy; and
- ensure that any proposed changes can be implemented quickly and efficiently.

Recommendation 5: The Committee recognises that it will not be possible to calculate a precise figure of the costs of the reforms to other areas of government and the justice system. However, the Ministry of Justice should set out in its Treasury Minute response:

- how it plans to work with other government departments such as Department for Levelling Up, Housing and Communities and the Department of Health and Social Care to better understand where reforms may have led to cost-shunting and the potential scale of these costs. This should include looking at the extent to which local authorities are funding immigration legal advice; and
- how it intends to work with HM Courts and Tribunals Service to improve available quantitative analysis on the impacts of litigants-in-person on the administration of justice, as recommended in the PAC's 2015 report.

Recommendation 6: The Ministry of Justice should set out in its Treasury Minute response how it plans to improve its ability to respond to emerging sustainability issues in a timely manner. This should include:

- how it plans to work with providers to keep the profitability of legal aid work in view;
- how it plans to implement the recommendations from the Criminal Legal Aid Board; and
- what mechanisms it will put in place to review the sustainability of civil legal aid

more routinely once its review is complete in July 2024

The Ministry of Justice is now required to formally respond to the PAC's report (referred to above as a Treasury Minute) but this will not happen for some time given the timing of the general election.
