<u>Party Manifestos - what do they say about justice?</u>

Now that the party manifestos have landed we have an idea about what the main parties are saying about the justice system. News flash – it ain't much.

Many thanks to Ro Jana and her team of parliamentary affairs elves for putting together this overview of justice and justice-related manifesto policies and proposals. Few will be surprised that the manifestos of Labour, the Conservatives, Lib Dems, Reform and Greens say very little about the justice system outside of crime and punishment, with legal aid mentions in the single figures across the five documents. The Lib Dems probably have the best offering, but our politically-astute colleagues have pointed out that that may well be because they don't expect to be in power, so can offer a lot more knowing their proposals will not be bothering Treasury officials anytime soon.

Our parliamentary influencing team has included a range of 'justice-adjacent' policy areas in the manifesto comparison table. This is because over the last couple of years we have broadened our influencing strategy to include policy areas and departments beyond the Ministry of Justice's responsibility for legal aid. The efficacy of public policy in relation to reducing homelessness, protecting survivors of domestic abuse and ensuring children with special educational needs receive appropriate support in school (for example) all depend in part of people being able to access specialist advice and representation. We

are therefore working with a wide range of partners to convince policymakers across government of the benefit of investing in advice services and the legal aid system.

So come the 5th of July we will know who is heading to Downing Street but, based on the manifestos, we are not likely to have a clear idea of the direction of justice policy. We will be advocating for the Ministry of Justice to complete the Civil Legal Aid Review, which was put on hold when the election was called just before the publication of the final reports and Green Paper on the future of civil legal aid. After a year of advocacy from LAPG and many other groups the Ministry eventually came round to publicly accepting that fees and scope are the critical issues for Ministers to address, and we don't want that momentum to be lost. Following on from our engagement with the justice teams of the main parties over the last couple of years, we've carried detailed analysis of prospective parliamentary candidates and we're watching polling closely so that we'll be ready to act as soon as the election dust has settled.

<u>Duncan Lewis judicially reviews the Lord</u> <u>Chancellor over legal aid fees</u>

Duncan Lewis Solicitors has filed a claim in the High Court challenging the government's failure to raise legal aid rates for immigration and asylum work. They claim that the Lord Chancellor is failing to fulfil his statutory duty to secure legal aid for the vulnerable individuals eligible for legal aid but struggling to find a lawyer. Duncan Lewis point out that there has been a 48% real-terms cut in rates since they were last increased in 1996.

<u>Legal Aid Agency launches consultation on the next Standard Crime Contract</u>

The LAA has launched an official contract consultation process on changes to the 2025 Standard Crime Contract. This follows <u>publication</u> in May of the Headlines Intentions document



detailing the LAA's plans to procure new contracts for 2025 and setting out some of the key anticipated changes.

The consultation process runs until Monday the 29th of July 2024. The current 2022 Standard Crime Contract ends on 30th of September 2025, so the LAA is consulting on a contract that is likely to be put out to tender this autumn and then commence on 1st of October 2025.

Members will recall that the LAA recently carried out a consultation process on one of the issues referred to in the Headline Intention document – the question of solicitor and CILEx qualification routes for duty solicitor accreditation. The LAA has confirmed that this issue remains unresolved following that consultation exercise. They are reflecting on the position following the recent consultation and any decision on the inclusion or otherwise in the contract will be one for new ministers.

If members have any comments on the issues covered by the Headline Intentions document please contact our Director of Legal Aid Policy, Kate Pasfield, so we can feed these through to the consultation process.

Police Station Representative and Supervising Solicitor data cleanse

A note has been sent to providers and supervising solicitors, explaining a data cleanse of police station representatives' (PSRs) details will be taking place from Monday 17 June to Monday 15 July. The cleanse aims to ensure that all contact details for PSRs are correct. A form was sent out to all supervising solicitors held on DSCC systems on Monday 17 June. Supervising solicitors should ensure the form is fully completed and returned, so PSRs can continue to undertake contract work.

<u>LAA Case Management Operations Report -</u> hints and tips from the LAA

At the last Civil Contract Consultative Group meeting on the 12th of June, discussions were limited to operational issues due to being in a period of pre-election heightened sensitivity. However we were provided with an updated **Case** Management Operations Report. The report comes in the form of a slides pack and provides stats on the LAA's operational performance over the previous quarter. The pack also provides hints and tips from LAA caseworkers on how to ensure applications and claims for payment are accepted first time. At 94 pages you might not want to read the entire pack, so we have set about below some of the useful guidance, hints and tips from the LAA:

- Page 10 hints and tips in relations to merits
- Page 25 hints and tips in relation to means
- Page 80 an overview of how and when to use the Online Support Service
- Page 82 top tips on issues such as billing, claiming, using CCMS and escape fee claim submissions

Domestic Abuse gateway evidence

In previous updates, we have discussed the issue of the LAA rejecting domestic abuse gateway evidence provided by medical specialists and support services on private law children applications. A number of family practitioners had reported that evidence that was previously accepted by the LAA was now being rejected. The LAA promised to carry out a review of some of these cases and provided their analysis on pages 17-21 of Operations Pack referred to above.

The LAA has also highlighted the exact wording



that needs to be used in gateway evidence letters, which you can find below along with template letters.
