# Early Legal Advice Pilot and Housing Loss Prevention Advice Service – professional competence and insurance risks

If you are participating in the Early Legal Advice Pilot (ELAP) or the Housing Loss Prevention Advice Service (HLPAS), you will have realised that you are being asked to cover areas of work which are not currently in scope and will only be in scope for cases run under these two scheme by virtue of the statutory instruments that have amended LASPO in very specific and limited ways. There is a danger that in participating in these schemes that the advice given (e.g. on welfare benefits and debt issues) has to be under the supervision of the Housing Supervisor who may have no direct experience or expertise of these complex areas of law. The scheme allow the use of agents, and those agents may be specialist in these areas, but responsibility for the quality of the advice remains with the named Housing Supervisor.

#### There are two main issues:

- professional obligations regarding competence and supervision; and
- notifying your insurers that you are carrying out work in a new area where there may not be the required expertise.

### **LAA Billing Guides**

At the latest Civil Contracts Consultative Group meeting on 21 September the LAA flagged up a couple of Guides:

Provider Billing After a Transfer of Provider CCMS Advanced Guide CCMS Billing with Counsel: This guide shows how providers should bill in CCMS if they have instructed counsel. It helps providers understand how to identify what counsel has been paid, as well as when the point of assessment is, and why the LAA needs both their claim and counsel's claim together for assessment in hourly rates cases.

ccms Billing After a Provider transfer: This guide shows how and when providers can claim all types of claims when there has been a provider transfer. It helps providers understand what they can claim, and when they can claim it, for claims that are made at both fixed fee and hourly rates as well as how to create the claim in CCMS to help the LAA say yes first time.

# New Ministers at the Ministry of Justice

The Rt Hon Brandon Lewis CBE MP is the new Lord Chancellor as members will know by now. Lord Bellamy remains in the team, leading the Lords, as a Parliamentary Under Secretary of State and retains the civil legal aid brief. Along with civil legal aid, Lord Bellamy covers human rights, judicial policy, private and public family justice and a range of other issues. Gareth Johnson MP is now a Parliamentary Under Secretary of State and has the criminal legal aid brief (along with, inter alia, courts and tribunals administration, including fees, criminal court recovery and court & tribunal reform programme delivery).



# Funding for the Social Welfare Solicitors Qualification Fund – please do share with members of your organisation who want to become solicitors

"The SWSQF is an initiative by the City of London Law Society, BARBRI and Young Legal Aid Lawyers ('YLAL') to provide financial assistance to aspiring solicitors working in social welfare law for organisations serving disadvantaged communities. The SWSQF funds the Solicitors Qualifying Exam (SQE) preparation courses and assessments. The fund works alongside other initiatives to provide greater access to justice and widen access to the legal profession."

This year it is hoped that applications can be taken from mid-October 2022 so if anyone in your organisation is interested they should watch the website for updates.

There are three key documents:



- Eligibility criteria (They have raised both salary and savings limits this year, to account for increases which may have been made re inflation. They are also adding a Universal Credit gateway to eligibility for those in receipt)
- Guidance for applicants
- Guidance for employer letter of support

# Civil Justice Council Consultation on Costs – Deadline now noon 14 October 2022



he deadline for this was originally 30 September and has now been extended to midday on 14 October. See:

This is a short and very well written consultation which on the face of it may not appear to affect legal aid lawyers that much. Indeed if you search (Control F) for legal aid the only mention is that Paul Seddon was involved on behalf of the Legal Aid Practitioners Group.

However, this consultation is part of the ongoing civil reform process since the Woolf reforms and, in particular the Jackson reforms and changes approved by the MoJ in September 2021 (found here). It feeds into a strategic and holistic look at inter partes costs i.e. remuneration of legal services through fees shifting, and how to ensure this provides access to justice including for vulnerable court users (which follows the introduction of Practice Direction 1A to the CPR last year). It will influence decisions moving forward, including:

- Pre-action costs and digitisation (linked to another CJC Consultation which can be found here)
- The expansion of costs budgets the MoJ has already recommended these for complex judicial reviews
- Fixed Recoverable Costs already being introduced for civil claims of up to £100,000

- damages from next April, Jackson LJ's recommendation was that they be used for damages of up to £250,000
- Whether Guideline Hourly Rates should be kept and if so then what they should be used for and the method/frequency of reviewing them (this follows the MoR's approval of new GHRs in 2021 recommended by the CJC in its final report <a href="here">here</a> with interim report <a href="here">here</a>

Inter partes costs recoveries are of course now vital to so many legal aid practices, many of whom use it to fund other cases/projects. There appear to be two main issues:

- The problems caused by Fixed Recoverable Costs; and
- Linked to that there is no mention of the introduction of legal aid rates for civil nonfamily certificated work set in 1994 (which, barring a c.1.5% increase in 1996 for franchisees i.e. what is now schedule authorisation, have never been increased but rather extended to appeal proceedings, reduced by 10%, and capped rates on high cost cases and exceptional work), where it was recognised that if legal aid was to be paid at below market rates, then inter partes costs would not be limited to these but be payable at market rates.

There is no mention at all in the paper of the effect of the proposals on legal aid lawyers but the CJC Steering Group on Costs is keen to hear views and examples from legal aid practitioners, particularly where these issues mean compromising bringing cases to court etc. This consultation covers such a broad spectrum of cases funded under legal aid and we need your views and experiences.

The CJC is looking at the effect of Fixed Recoverable Costs and expanding them, rather than reviewing whether or not the FRCs on £100k claims should come in as planned. However, we will still be raising this issue in our response.

send us a copy of your response that would be very helpful. Essentially swings and roundabouts in civil are being more and more about losses on the swings and less and less about any gains on the roundabouts. It would be particularly helpful to send the CJC (and us) examples i.e. evidence that recovery on inter partes cases is supporting other work e.g. case loads and projects. We do need data to feed into the CJC.

### **Human Rights Act**

In our last Update we referred to the campaigning of a coalition of groups to save the Human Rights Act. There was supposed to be a Second Reading of the Bill on 12 September but the new government decided not to proceed with the proposed 'overhauling' of the Human Rights Act.

This does not mean that the issue has gone away. The attempt to change it was very much Raab's baby and as he is not in the new Cabinet and indeed not in favour with the new Prime Minister, there was less interest in continuing with this. More importantly, the proposals were very poorly thought through and poorly drafted. They would have caused the Lords in particular a lot of concern. That being said, it is highly likely that the new Government will introduce a fresh attack on the Human Rights Act, which means that we must remain vigilant and continue the fight.


