Ministry of Justice Civil Legal Aid Review

At the Civil Justice Council Conference on 18 November 2022 Lord Bellamy KC confirmed that the Civil Legal Aid Review will start at the end of this year. So what do we know about the Review? Well, very little, as the MOJ is yet to publish terms of reference, objectives or a timeline. Discussions with civil servants have also revealed scant detail, so it is difficult to know exactly what the MOJ hopes to achieve through this Review. We have been told that the Review is likely to take 12-18 months, and that the MOJ will be investigating 'quick wins' by, for example, improving processes and contracts and reducing administrative burdens. The big question of course remains whether the MOJ will be able to make the case to Treasury that fees must increase if we are to see a reversal of the trend that has seen provider numbers decline so dramatically over the last decade. More work must also be done to increase provider numbers to respond to soon-to-be announced changes to the means test, which will lead to more pressure on over-stretched services.

We have opened discussions with The Law Society, The Bar Council and a range of other membership and representative bodies to ensure that there is a co-ordinated response from the sector to this Review. Along with scheduling regular meetings to align our work on this, we have started a literature review and are considering how best to obtain additional information from practitioners and provider organisations. Fixed Recoverable Costs pushed back to October 2023

Fixed costs extension delayed to October 2023

extension of FRCs has been put back to October next year. This was confirmed by Lord Bellamy KC in his address to last week's CJC conference. He noted that 'these reforms have particular implications for housing cases, and I am grateful for the constructive input of housing providers which we continue to consider'. LAPG has been working closely with HLPA and a number of other bodies to make the case for a total exemption for housing cases from the extended FRC regime, so this postponement will enable further dialogue with MOJ officials.

HPCDS contracts extended to 31 October 2023

On 16 November the LAA announced that they intend to offer all existing providers of Housing Possession Court Duty Schemes (HPCDS) an extension of their current contract from 1 October 2022 to 31 October 2023 with a break clause which can be exercised in July 2023. Why? This will allow the LAA to put in place new contracts to deliver the Housing Loss Prevention Advice Service (see below). This is the replacement service for HPCDS.

The LAA intended to write to all current HPCDS contract providers to confirm their intentions and formally issue extension offers over the course of the following few days. Providers will need to sign into the contract extension, or where they do not wish to do so, confirm this to the LAA by the date set out in their letters.

LAA launches tender for Housing Loss Prevention Advice Service to replace HPCDS

The tender is now live for the new Housing Loss Prevention Advice Service designed to deliver both early legal advice and in-court duty work. The LAA is also inviting applications for the delivery of Housing and Debt contract work to support delivery of the HLPAS. "Housing Legal Aid HLPAS Tender Launched: some professional conduct issues to consider.

The Legal Aid Agency has now launched a tender for the new Housing Loss Prevention Advice Service (HLPAS) that will replace the existing Housing Possession Court Duty Scheme (HPCDS) from 1 August 2023. HLPAS augments court duty scheme work with provision of non-means, non merits tested earlier advice in housing as well as welfare benefits and debt from the point where the landlord or mortgage lender has issued a notice of intention to repossess. The tender is open to current providers in the Housing and Debt category who meet the tender requirements as well as new entrants who would also need to apply for a standard Housing and Debt



contract in order to perform HLPAS work. Further information about the tender can be found here.

Welfare benefits and debt work has been brought back into scope for legal aid provided under HLPAS having been largely removed from scope in 2013. Whilst this is a welcome development it is widely acknowledged that specialist welfare benefits and (non-mortgage) debt knowledge within the legal aid sector has been substantially depleted. This is recognised by the Legal Aid Agency and for pragmatic reasons there will be no specific contractual legal competence standard for supervisors regarding welfare benefits and (nonmortgage) debt work undertaken under HLPAS. However, in this instance compliance with LAA contractual requirements will not necessarily mean that providers without a welfare benefits and debt specialist will be compliant with the SRA rules on service and competence. Providers considering a bid to offer HLPAS advice should carefully consider their service and competence obligations under <u>section 3 of</u> the SRA Code of Conduct for Solicitors and section 4 of the SRA Code of Conduct for Firms. As specialist welfare benefits and debt work will be new areas for many, providers should also ensure that they will be covered by their professional indemnity insurance."

We asked the LAA to set out its commissioning plans over the next year, and to explain the rationale behind the tender processes and contract lengths. They have noted:

The initial plan had been for HLPAS contracts to start at the end of April 2023. However there were delays to decisions being taken and the SI being laid due to the changes in Ministers and the death of the Queen. The Civil Legal Aid (Housing and Asylum Accommodation) Order 2022 which was laid on 17th October and can be found here sets out that HLPAS will now commence on the 1 August 2023.

The tender for the HLPAS contracts should commence this week, new providers who do not currently hold a 2018 Housing and Debt contract can bid for one as part of this process if they are also bidding for HLPAS. The intention is that HLPAS contracts will be for a 13 month period and end on 31st August 2024.

Existing HPCDS contracts have been extended to ensure that there was no gap in provision between 29th April 2023 and the commencement of HLPAS on 1 August 2023. The HPCDS contracts have been extended until 31st October as a contingency in case there are any delays to the award of HLPAS contracts, it is a competitive tender process and there has

previously been litigation in relation to the awarding of HPCDS contracts. If there are no delays then the break clause will be exercised and the existing HPCDS contracts will end on 31st July 2023 and HLPAS contracts will commence on 1 August 2023.

The existing 2018 face to face contracts have been extended until 31st August 2023. The contract variation letters will be sent out early next year and providers will have to actively accept the variation. There will be a deadline to notify the LAA of acceptance or rejection of the variation. The tender activity for new 2018 contracts (which is for new providers and existing providers who want new categories/offices) will commence early 2023. New providers who want Housing contracts but did not want to bid for HLPAS can bid.'

Latest operational update on the Early Legal Advice Pilot

After asking the LAA to provide an update on the status of the pilot, the following has been provided to membership and rep bodies:

'There are 4 providers participating in the pilot, one in Middlesbrough and 3 in Manchester. Contracts commenced on the 31st October but it will take a while for participants to filter through for advice.

In Manchester, pilot invitation letters will be sent out by Manchester City Council within the same envelopes as their council tax first reminders letters. These letters are sent at least weekly.

In Middlesbrough, pilot invitation letters will be sent out by Middlesbrough Council to those who will separately receive Council Tax Liability Order letters. These letters are sent monthly.

Potential participants will be sent a leaflet in the post containing information about the pilot. It explains that:

 If they are currently experiencing any issues or disputes with housing, debts, or benefits, they may be eligible for up to three hours of free advice and support from a professional lawyer.



- They are invited to apply to participate and see if they are eligible, which they can do through an online survey or by phone (which checks whether they have legal need in the relevant areas). The contact details and links are in the letter for them to call for free or access online.
- Participants are told that if screened in as eligible for the pilot, through a few short questions, they will then be asked to answer some further survey questions that will take 10-15 minutes, for which they will receive a £15 gift voucher as a thank you for completing.
- They are told that half the people who complete the survey will be randomly selected to receive the legal advice. If they are not selected, we will point them to <u>other</u> relevant local services that could assist.

The leaflet also contains an FAQ sheet that explains that taking part is voluntary, how personal information will used, and gives contact details should they have any queries. It gives further details about the pilot, and reiterates that:

"The Early Legal Advice Pilot (ELAP) seeks to understand whether free legal advice and support helps people resolve their problems. To do this, half of those people who choose to take part in the pilot, and are eligible, will be selected to receive 3 hours free legal support. The other half will be told about existing local services that might be able to help and continue as normal. These groups are selected at random, to help the research team to see if the advice makes a difference. This is known as a Randomised Controlled Trial (RCT). You will know which group you are in after you complete a survey."

Numbers might also fluctuate over the course of the pilot. In Manchester where there are multiple providers, and, with permission, contact details for each provider have been shared in the event they need to allow some coordination. MoJ also intend to host check-ins to understand how the work and capacity is being managed.

Each Council has said they are happy to pause sending out invitations if there has been a high take-up rate.'

LAA considering changes to the next Standard Crime Contract

The LAA has invited the contract consultee bodies (LAPG, The Law Society and The Bar Council) to begin discussions on potential changes to the next Standard Crime Contract. Their aim through this piece of work is to work with the consultee bodies 'to explore ways to ensure an effective contractual model whilst reducing unnecessary administration to providers to deliver services, and to implement learning from the shift in working practices employed during the Covid-19 pandemic'. To help initial discussions, which commence next week, the LAA has noted that they are exploring the following themes:

- Access (How clients access services)
- Allocation (How work is allocated to legal aid providers)
- Quality (What the LAA's suite of quality measures should look like in the future)
- How we contract (in what ways could we reduce unnecessary barriers to entry)


The Bar Council launches its latest report on legal aid - 'Access denied: The state of the Justice system in England and Wales in 2022'

The report paints a worrying picture of the current state of access to justice in England and Wales.

Key findings include:

• 239 courts closed since 2010 leaving clients extremely anxious that they won't be able to





- get to their hearings
- Cuts to legal aid funding having a catastrophic impact on the ability of people to access justice
- A mixed experience of remote justice that requires further investigation
- Crumbling court buildings that are not fitfor-purpose, including leaks, infestations, and a lack of basic facilities
- An increase in litigants in person, due to reductions in the availability of civil legal aid, resulting in cases taking longer and costing more – the opposite of what LASPO set out to do
- Barristers diversifying away from legal aid work due to workload pressures and poor remuneration, further reducing the capacity of the system
- Worrying political attacks on the rule of law and anti-lawyer rhetoric that undermines confidence in the justice system and contributes to burnout and stress

- Case backlog and the state of the court system


