# LAA cyber-attack latest

Fallout from the LAA's cyber-attack continues to rumble on, with no resolution currently in sight and providers finding the LAA's workarounds increasingly difficult to navigate. The LAA is sending out bulletins every couple of days with updates and clarifications following the introduction of the new enhanced business continuity arrangements on 27 June.

We are still receiving emails every day from our members confused about some of the LAA's comms. Please do continue to get in touch with <u>kate.pasfield@lapg.co.uk</u> if you have a query or just need support with the ongoing crisis. A few of the queries we have received are set out below in case you are also confused/concerned:

### **Contingency payment escalation process**

We are hearing from members who are finding that their civil contingency

have been doing through CCMS. The LAA has put an 'escalation process' in place whereby providers can request a higher payment through their Contract Manager. However, it has not been well publicised with members unaware of the process and from what we can see, the LAA's comms do not explain adequately what providers need to do, other than saying that they should contact their Contract Manager. You can read the <u>contingency payment provider guide here</u> and you will see reference to what to do if your payments are not enough in the Q&A at the end.

If you do wish to make use of this process, we understand that you will be sent a spreadsheet and guidance on how to fill it out by your Contract Manager – titled the <u>Escalation Spreadsheet Picture Guide and Guidance</u>. There are deadlines involved in using this process to receive the higher payment instead of the regular weekly payment. You should speak to your Contract Manager as soon as possible if you need to use this process.

(**Note** that the links above are to versions 1.4 and 1.8 of the respective documents, which date from late June, so you may receive updated versions from the LAA).

We have asked the LAA to make their comms clearer about what providers need to do in this situation.

### Delegation and potential for recovery of payments on audit

Members have been expressing their concerns about using delegated functions so widely under the new contingency arrangements in civil and crime and questioning whether the LAA might seek to recover monies on audit where mistakes are discovered. In response the LAA has said the following in their most recent comms:

We have also added further clarity to our approach on audit. Recognising the need for providers to have confidence in their ability to make delegated decisions, the LAA does not intend to recoup any payments following audit, on cases where a good faith and proportionate approach has been demonstrated to implementing the contingency processes in line with the guidance.

# **Civil Legal Aid News**

On 2 July, <u>the MoJ published the outcome of the Housing & Debt and</u> <u>Immigration & Asylum fees consultation</u>. As was anticipated, they are bringing in uplifts to fees in line with the consultation, which will mean increases to hourly rates to a minimum of £65.35/£60.30 (non-London/London), alongside a proportional increase for fixed fees. The government estimates that overall spending in these categories of work will increase by 24% for housing and debt, and 30% for immigration and asylum.

<u>As we said in our response to the consultation</u>, whilst we broadly support the principles underpinning these proposals, we remain deeply concerned that the uplifts will not be sufficient to address the challenges around sustainability, retention and recruitment of staff, and profitability. We also remain extremely concerned that there appears to be no progress towards increasing fees in other categories of legal aid and hope that the MoJ will now seek to address that.

# <u>Crime and prison law – proposals for solicitor fee scheme reform</u>

This MoJ consultation closed on Friday, 4 July 2025. Many thanks to the various people who contributed to our response including the crime and prison law specialists on our Advisory Committee, Young Legal Aid Lawyers, the Association of Prison Lawyers and the LCCSA.

- Harmonisation of the police station fee scheme, with all attendance fees increased to £320 excluding VAT
- For work in magistrates' courts, including the Youth Court, a 10% fee uplift
- For work in the Crown Court, the introduction of a fixed ratio of 65:75:100 for guilty plea, cracked trial, and trial basic fees in the Litigators' Graduated Fee Scheme (LGFS)
- To increase some basic fees for trials by between 33% and 35%
- An increase to fees for work done in prisons by 24%

Whilst the proposals in this consultation are largely welcome, we made the point that they are unlikely to be sufficient to improve the sustainability of criminal legal aid work, and that there are some glaring omissions from this consultation, such as an increase in the underlying hourly rates for police station work and the introduction of interim payments for magistrates court work.

# **Crime contract signatures**

The LAA has said that because of the ongoing cyber security incident, they cannot issue new contracts for signature for online acceptance on CWA. As a result, they are sending out contract documentation via email from 1 July. This process will take up to 3 weeks to complete.

This relates to tenders under Stage 3 of the Crime Contract procurement process for those wishing to deliver criminal legal aid services from 1 October 2025 to 30 September 2035 under the 2025 Standard Crime Contract.
