LAA cyber-attack latest - pilot to test new digital interface

As noted in their email bulletin yesterday (23 July), the LAA will now be sending out bulletins on a weekly rather than daily basis. Look out for the next LAA missive next Wednesday. The LAA has noted that any critical updates will be sent out immediately and they will continue to update the incident page on gov.uk.

Please also note that both the <u>guidance for the average weekly payment scheme</u> and the <u>FAQ page</u> were updated yesterday. Please make sure you keep a regular eye (Ed – what is an irregular eye?) on these web pages and guidance documents as they are routinely updated in response to the feedback that we and other rep bodies are providing.

The big news this week from Albert Square, sorry we mean Petty France, came on Tuesday, with the announcement that the LAA is launching a new *Sign in to Legal Aid Services* platform. This is replacing the portal you have all come to know and admire. The LAA noted that "this new secure platform will allow Legal Aid Providers to login, and - once they are available - to access Legal Aid Agency digital services such as CCMS. This is an important step in returning our services to secure operation".

The LAA has created a pilot group of 70 providers to test the new interface. The short pilot will "focus on identifying and removing any anomalies with the onboarding process, ahead of undertaking the onboarding process for all users nationally. Further information regarding the national rollout for onboarding will be shared over the next fortnight". Yes, that is a lot of onboarding. To improve security, users of the new system will be required to confirm their identity.

Crucially, the LAA has also noted that no actual LAA digital services will be available before September. The onboarding process will only give access to the portal – it will not give access to CCMS or CWA or any other services. They have also not said which services will be available after September, or the order in which they intend to restore services.

Compensation claims against the LAA

The Law Society is advising providers to keep detailed records of all the extra administration involved in undertaking legal aid work because of the data breach. They are looking into the possibility of providers claiming compensation for this time from the LAA. We will update you on this when we hear further. We are also seeking advice on this, and have asked the MOJ to consider creating a compensation scheme that recognises the severe impact that this incident has had on providers. We do not believe that providers should have to maintain detailed records about the impact of the LAA withdrawing its digital systems on top of all the chaos, stress and additional admin that has been created by the LAA's contingency arrangements. However the MOJ has not formally responded on this point. We'll keep you posted.

Weekly payments and the escalation process to alter payment amounts

A number of members have been in touch to express concern that their weekly contingency payments are insufficient to cover their weekly outgoings. Many have specifically noted the impact this is having on managing their ability to make payments to experts. An 'escalation process' exists to alter your weekly payments to cover disbursements and other case-related costs and to increase or decrease your weekly payments. Please speak to your Contract Manager about this as they will explain the process and provide you with the forms to complete to claim a

different amount.

MOJ considering an Interest on Lawyer's Client Accounts Scheme – have your say

Yesterday (23 July) you may have received an invitation from the MOJ (via a new address: additionalfunding@justice.gov.uk) to attend one of three upcoming roundtable meetings to share your views about the potential creation of an MOJ scheme to collect interest from lawyer client accounts. The MOJ notes that ILCA schemes are "operating in jurisdictions in the USA, Canada, and Australia. These schemes generate funding for various access to justice projects by capturing interest earned on pooled client funds held by law firms".

If introduced, the MOJ would utilise the funds for "key areas" of the Legal Support Strategy "including access to justice". LAPG sits on an advisory group trying to influence the shape, purpose and activities of the Legal Support Strategy. The Terms of Reference of the group can be found here. The Legal Support Strategy seeks to identify how to make the legal support system more effective, efficient, and sustainable. However it specifically excludes thinking about the legal aid scheme as this is the preserve of different policy teams within the MOJ. Whilst all the MOJ policy teams are expected to work together in a coordinated way, the Legal Support team's projects currently focus primarily on the non-legal aid aspects of the advice ecosystem. We have therefore raised concerns with the MOJ that if they introduce an ILCA scheme, any funds raised should be used to make the legal aid scheme more accessible and sustainable.

The MOJ has noted that they are particularly interested in hearing from you if:

- You work at a law firm of any size that undertakes a mixture of legal aid and privately paid work and hold client money in a pooled client account.
- You have an interest in providing views on the potential impact of an ILCA scheme on legal aid firms.
- You have a working understanding of your firm's financial model.

The online roundtables will run for approximately 60 minutes on the 6^{th} , 11^{th} and 113^{th} of August. You have until 1^{st} of August to express an interest by completing this form:

<u>2024 Standard Civil Contract tenders – amendment notice published 22 July 2025</u>

Since December 2024 the LAA has been <u>inviting tenders for the 2024 Standard Civil Contract on a rolling basis</u>, as opposed to only enabling applications during an open tender process. They call this the 'always on' process which allows tenders to be submitted at any time, with the significant advantages of no fixed deadlines and the ability to correct errors in those tenders. The LAA has received a steady stream of tenders since December and a high proportion of those have led to the award of contracts in recent months. This process is open to new providers, and to existing providers who wish to expand into a new category or procurement area.

This week the LAA <u>published an Amendment Notice</u> updating the following areas of their application guidance:

- Application process see paragraph 3.3
- Incomplete tender see paragraph 4.3
- Existing 2024 Standard Civil Contract Holders: New Offices and Office Moves (same Category of Law) – see paragraphs 7.3 and 7.4
- Existing 2024 Standard Civil Contract Holders: New Categories see paragraph 7.5
- Issue of Contract documentation see paragraph 15.1

Updated CivAPP8, CivAPP8A and CivAPP11

A reminder that in the new (old) world of having to use 'paper' civil legal aid forms that we find ourselves in, the above forms have been amended to include a field for the applicant's first name rather than their initials.

On 16 July the LAA commenced a tender process for two new CDD Contracts to deliver 24/7 telephone-based legal advice from 4 May 2026. These services support individuals detained at police stations in England and Wales for non-indictable offences.

Justice Committee launches new inquiry into access to justice

The Justice Committee <u>launched a new inquiry</u> yesterday (23 July) into access to justice in England and Wales.

Announcing the inquiry the Committee said:

'MPs on the cross-party Committee chaired by Labour MP Andy Slaughter will examine the current state of the legal services and representation market, and how it, and associated operating pressures, affect access to justice.

It will also look at the impact of those acting without legal advice and / or representation on access to justice and the ways in which the legal services and representation sector is adapting post LASPO 2012 to secure access to justice across civil, criminal and family law.

The inquiry will also assess potential new funding options and the scope for future

innovations and potential adaptation of services, funding, regulation and technology to support access to justice.

The Justice Committee previously undertook a broad inquiry on the Future of Legal Aid in 2022-23, looking at the challenges facing legal aid clients and providers and how they might be tackled. It built upon work undertaken by the Committee in 2015 on the impact of changes to civil legal aid under Part 1 of the Legal Aid, Sentencing and Punishment of Offenders Act 2012.'

Written evidence can be submitted to the inquiry up to 30 September 2025. The Committee will also hold a series of oral evidence sessions. Visit the Committee website for more information about the Terms of Reference, which sets out the issues the Committee will be exploring.
