Registration for 'Sign-In to Legal Aid Services' - Action Required by 22nd August

In case you haven't seen it or are just too jaded to read any more LAA updates on the cyber-security breach, the latest set of comms to providers dated 6th August 2025 informs us that from that date, the LAA began to collect the information needed to onboard all users to 'Sign In to Legal Aid Services' (SILAS). This is the

new secure version of the portal to give access to LAA's digital services, although those services will not be available to you straight away. This follows on from a short pilot into the onboarding the process.

The LAA say that they are commencing this process now to ensure that users' accounts are verified and ready for when the SILAS platform becomes available from September (date not yet specified).

We understand that even once you have completed the sign-up process, no digital services will be immediately available. The LAA want to ensure that when services do resume, all users have been onboarded successfully. They are saying that services will be restored in phases. We have asked the LAA to provide more information about this phased return of services including a timetable, and the LAA have promised an update in the next week or so.

The latest LAA comms describes the process that you will need to follow. You should also by now have received an email from your Contract Manager confirming what information you need to provide and how to submit it to the LAA. Please contact your Contract Manager if you have not yet received this email.

We understand that once the LAA receive the necessary information, they will confirm next steps including how to verify your account.

Other LAA announcements relating to the cyber-attack

The same comms has several useful bits of information towards the end, in case you didn't make it that far. Please note the information relating to payments over August:

Bank Holiday Payment Dates

Due to the bank holiday on Monday 25 August, payments due on that date will be made on Tuesday 26 August.

Civil Billing

To accommodate the bank holiday, any opt-ins for the Average Payments for Civil Representation scheme submitted during the week commencing 18 August should be received by 12 noon on Tuesday 26 August to allow for payment as normal on Monday 1 September.

Monthly Claim Submissions

We kindly ask that this month's Contingency Monthly Claim Submissions are made as early as possible, ideally by 12 August, so that we can accommodate for the bank holiday and the impact on our payment schedule. We will continue to accept submissions received up to 20 August but will be unfortunately unable to make payment for submissions received after this date until next month

There has also been an FAQ added on the process for refunding client contributions.

Guardian article on data breach

LAPG CEO, Chris Minnoch and LAPG Co-Chair, Jenny Beck KC (Hon) were interviewed by The Guardian for this article where they highlighted the scale of the problems faced by legal aid providers as a result of the LAA's data-breach:

<u>Legal aid cyber-attack has pushed sector towards collapse, say lawyers | Legal aid | The Guardian</u>

Along with placing <u>parliamentary questions</u> and direct liaison with the MOJ and LAA, we have been trying to raising awareness of the practical implications for providers and clients of the LAA taking systems offline. We're particularly interested in the issue of the MOJ making compensation available to providers for the additional costs associated with the contingencies processes, and in ensuring that as the LAA restores systems it also uses this opportunity to improve them. We're concerned that there is a low level of awareness across government and the media about the impact of the data breach, which may mean a lack of transparency and accountability and a lack of urgency to restore and improve systems. If you would like to assist us to raise awareness about the impact of the data breach please do get in touch.

What do you do when the 16-week delegated period expires on your case?

We have asked the LAA to explain what providers need to do once the 16-week

delegation period has expired. The contingency guidance currently says: "The LAA will apply the limitations at the point we issue the certificate, any existing grants under Delegated Functions which have not been issued by LAA will include these new limitations also." The LAA have now been issuing certificates since 16th May, when CCMS went down and by our maths, this means that the timeframe for some cases will expire during the first weeks of September – which is not that long away.

We will share the response from the LAA with our members on receipt, and the LAA have promised a solution in good time.

CW3: extension of upper cost limit in Controlled Work cases

The LAA has updated the CW3A IMM, CW3B IMM, and CW3C IMM Controlled Work forms for extension requests on hourly rates and graduated fee cases.

Legal aid tender opportunities in Housing and Debt

The LAA is keen to encourage contract tenders for Housing & Debt and Welfare Benefits contracts in a worryingly large number of geographical areas. They say that the re-opening of the process to apply for the 2024 Standard Civil Contract is open to all geographic areas and categories of law, but are particularly keen to increase supply to Housing, Debt and Welfare Benefits services in 18 specific procurement areas. This indicates that the LAA is concerned about very low or a lack of supply in these areas.

While it is positive that the LAA is actively trying to encourage an increase in supply across the country, and in these 18 areas in particular, this is another worrying sign of the declining number of suppliers. As we noted in <u>our response</u> to the <u>Housing and Immigration Fee Increase consultation</u>, the government needs to do so much more than introduce small fee increases if it wants to make this work financially viable and increase supply. Tinkering around the edges with tender processes and minor contract changes won't arrest the decline in provider numbers that we have seen over the last 15 years.

Support for providers who assist migrants and asylum seekers

Migration Exchange has updated its handbook and resources for organisations experiencing increased threats due to the assistance they provide to refugee and migrant communities.

MEX explain that:

This handbook is for organisations and individuals working with refugee and migrant communities, as well as those supporting racialised communities. The aim of this Handbook is to provide useful and readily accessible resources which individuals and organisations can access to boost their safety and security of staff and volunteers in times of crisis.

Criminal Legal Aid News

Passported benefits guidance

The LAA and LCCSA have met to discuss the passported benefits guidance for criminal legal aid cases, and have agreed the following 'translation' which hopefully is clearer than the LAA version. Although the LAA version has not been amended they have said that they accept the following as formal guidance that providers should follow:

- 1. When we first engage a client (at or before the first appearance) who is on a passported benefit we ask them if they have evidence of their benefits.
- 2. We put an attendance note on our file to say that we have asked this question.
- 3. If the client cannot provide evidence, then the application should be assessed as non-passported.
- 4. So, we should obtain information as normal of the type of benefit, amount, and frequency and use this to complete the application (using the 'workaround').
- 5. You suggest using the online means calculator (https://www.gov.uk/guidance/criminal-legal-aid-means-testing), but it is not mandatory to do so.
- 6. We include a 'chaser' in our client care letter requesting clients respond with evidence of their benefits.
- 7. Nothing has changed in relation to NINO's it is a mandatory requirement to obtain a NINO for anyone in receipt of a passported benefit.
- 8. We do not need to do this for cases that finished before 16 July so only on new cases going forward.

UK/France Small Boats Deal

The MOJ has provided the following updates regarding the UK/France Small Boats Deal:

- The UK-France Agreement on the Prevention of Dangerous Journeys has now been ratified and has been published here: https://www.gov.uk/government/publications/ukfrance-agreement-on-the-prevention-of-dangerous-journeys-cs-france-no22025
- Under the new UK-France pilot, any asylum claim submitted by a migrant
 who has crossed the Channel will be considered for inadmissibility and, if
 declared inadmissible, the Home Office will organise readmission of the
 individual to France. Further details of the inadmissibility process can be
 found in the relevant Home Office caseworker guidance Inadmissibility third country cases: caseworker guidance GOV.UK
- For those coming to the UK under the agreement, an individual in France will submit an Expression of Interest application to the new route and the Home Office will make a decision once they have undergone biometric checks. Anyone who had arrived by small boat and returned to France will not be eligible for the legal route to the UK. The Immigration Rules to implement this part of the process were laid in Parliament on 5 August 2025, and further details are set out in the Statement of Changes to the Immigration Rules and supporting documents published here:
