LAPG Annual Legal Aid Conference - 20 October 2025

We are delighted to announce that we are now taking bookings for this year's LAPG Annual Legal Aid Conference, which takes place on Monday 20th of October 2025 at A&O Shearman's offices in London.



Earlier this year the legal aid sector was ambushed by the news that the LAA's digital systems had been breached by a cyber attack. Discovering that millions of pieces of sensitive client and provider data, dating back as far as 2007, had been stolen, the LAA took its systems offline on 19 May. The result for

providers has been months of chaos, stress and anxiety as you try to negotiate changeable, complex contingency measures and a vacuum where once there stood a billing process. This year's conference will therefore include a range of content focusing on the LAA's contingency measures and how we claw our way out of the crisis. We're bringing together practitioners, policy specialists,

management consultants and LAA experts to discuss how to manage during business as very unusual, and how we get back to some level of normality.

Along with cyber breach content, we have our usual mixture of workshops covering issues relevant to legal aid lawyers in their daily practice as well as management sessions for all levels of manager. We're catering for students and junior lawyers and have sessions of general interest to all such as legal aid policy development and cost maximisation. Our conference therefore has more than a little something for everyone, along with a chance to network and benefit from the support and camaraderie that comes from being part of this wonderful sector.

Our keynote will be delivered by Gina Miller, the campaigner who twice took on the government in relation to important constitutional principles. The Article 50 and prorogation cases sought to uphold parliamentary sovereignty and ensure that the government acts lawfully, issues close to the hearts of legal aid lawyers.

We have extended an invitation to the Minister with responsibility for legal aid and court services, Sarah Mackman MP, and will adjust the programme if she is able to attend.

This year's plenary sessions will cover two topical, business-critical issues: the risks and rewards of adopting AI systems and civil and criminal legal aid policy development. The second plenary will be adjusted depending on where we are with the restoration of the LAA's digital systems.

The cyber attack on the LAA's IT systems has had profound impact on both legal aid providers and clients trying to access help and support. Over recent months, the LAA has introduced a range of contingency measures after deciding to take all of its digital systems offline to prevent further attacks and improve system security. Panel members will discuss the state of play by the time of the conference, looking at issues such as ongoing contingency measures, the recoupment of the contingency payments made to providers, and compensating providers for the additional costs they incurred as a result of the data breach. (Note: if LAA systems are restored and legal aid processes have returned to business as usual, this panel will consider wider legal aid policy and campaigning issues.)
