# **Cross-Cutting Legal Aid News**

#### Update on the LAA's plan for restoration of their digital services

The latest official LAA comms to legal aid providers landed on 10<sup>th</sup> September and focuses on the upcoming restoration of criminal legal aid services. It also covers updates to FAQs on SILAS regarding third party ID verification and use of authenticator apps for civil and crime providers.

The expected timeline for the phased return of civil and crime services is below (although subject to various caveats from the LAA around the testing and stability of systems):

- In mid-September, Crime Apply and Submit a Crime Form will be available for access. Subject to testing and security reviews, we hope to restore access in week commencing 15 September 2025.
- From mid to late September, Civil Apply and CCMS will be available for access.
- Services relating to functionality previously provided by CWA are expected to return from October. [Note that the LAA has indicated that CWA will actually be restored in November]

Following pressure from LAPG on behalf of our members, the LAA has relented on the requirement for providers to have to verify third-party personnel and retain copies of ID documents for audit purposes. The LAA have said that third-party personnel, such as costs specialists, can now verify themselves which will no doubt be a huge relief to many.

The LAA cyber security incident FAQ page is here and was last updated on 10 September.

We are expecting the next set of official LAA comms early this week, with further clarification over the timetable and process for restoring civil legal aid services like CCMS.

#### Overview of the LAPG member meeting to discuss the LAA's plans

A big thank you to everyone who attended our Member Meeting on 9 September on the LAA data breach and their plans to restore digital systems over the coming weeks. We had over 100 people at the meeting from across our membership, which demonstrates how concerned people are about the situation.

For those that attended, we hope you found the meeting useful and went away with a better understanding of the LAA's plans and the steps you need to take over the next week or two before CCMS comes back online.

We are expecting further comms from the LAA on the planned restoration of CCMS and CWA early this week, so please do look at for that (from the <a href="mailto:legalaidbulletin@labulletin.org.uk">legalaidbulletin@labulletin.org.uk</a> email address) for the latest official position.

Following the meeting we fed back to the LAA the continuing anxiety around the end of weekly contingency payments, the commencement of the recoupment process and the potential restriction of access to CCMS amongst other issues. We're hoping those concerns will be reflected in the LAA's next set of comms and in their planning for the transition period once their systems are restored.

For those who were unable to attend the meeting, we discussed the following issues and provided information about what we know about the LAA's current concerns and plans:

- The phased re-instatement of CCMS
- Loading on CCMS and stability of the system LAA's plans to monitor demand and potentially restrict access if CCMS becomes unstable
- Contingency planning for any future disruption to digital systems
- LAA capacity to input and process applications, amendments, bills etc.

- Entering information onto the system: What will the LAA do? What will providers need to do?
- Indicative timescales for receiving payments
- Preparation for system restoration getting organised and ready, including liaison with counsel
- When will average weekly contingency payments end and when will recoupments commence?
- What happens in 'hardship' situations?
- How will the LAA assess provider decisions taken under delegated functions?
- Compensation for providers for losses incurred during the outage
- CWA restoration

We're planning another Member Meeting approximately 1-2 weeks after CCMS comes back online. ## <u>LAPG Annual Legal Aid Conference – 20 October – reserve your discounted</u> <u>place</u>

Join us for this year's LAPG Annual Legal Aid Conference on Monday 20 of October 2025 at A&O Shearman's offices in London.

Given the ongoing and evolving situation facing all providers, there is a heavy emphasis in this year's conference programme about the impact of the LAA data breach, the contingency processes and the LAA's plans to restore its digital systems. We'll adjust the content prior to the conference based on the state of play by 20 October.

Along with cyber breach content, we have our usual mixture of workshops covering issues relevant to legal aid lawyers in their daily practice as well as management sessions for all levels of manager. We're catering for students and junior lawyers and have sessions of general interest to all such as legal



aid policy development and cost maximisation. Our conference therefore has more than a little something for everyone, along with a chance to network and benefit from the support and camaraderie that comes from being part of this wonderful sector.

Our keynote will be delivered by Gina Miller, the campaigner who twice took on the government in relation to important constitutional principles. The Article 50 and prorogation cases sought to uphold parliamentary sovereignty and ensure that the government acts lawfully, issues close to the hearts of legal aid lawyers.

We have extended an invitation to the Minister with responsibility for legal aid and court services, Sarah Sackman MP, and will adjust the programme if she is able to attend.

This year's plenary sessions will cover two topical, business-critical issues: the risks and rewards of adopting AI systems and civil and criminal legal aid policy development. The second plenary will be adjusted depending on where we are with the restoration of the LAA's digital systems.
