Tender processes

<u>Housing and Debt Contract Work - Oldham,</u> <u>Rochdale, Warrington & Halton</u>

On 15 February 2023 the LAA opened a tender to deliver Housing and Debt Contract Work in 3 procurement areas, listed below:

- Oldham
- Rochdale
- Warrington & Halton

The Housing and Debt Contracts will be offered from 1 April 2023. The LAA is offering an unlimited number of contracts for housing and debt services in these three procurement areas.

HLPAS re-tender (Reminder)

This was flagged up in LAPG Update 3.

The LAA is re-tendering for HLPAS (12 areas): The deadline for submitting tenders for this procurement process is **12pm on 1 March 2023**. The tender pages have been <u>updated on GOV.UK here</u> and the LAA has also <u>published a news story here</u>.

The twelve areas are Bedford, Birkenhead, Crewe, Darlington, Dartford, Durham, High Wycombe, Hull, Liverpool, Teesside, Telford, Wigan.

Housing Loss Prevention Advice Services (HLPAS) and Housing and Debt services from August 2023



An amendment notice has been published. This deals with the verification process. See here.

Family Legal Aid SI

The LASPO Act 2012 (Legal Aid: Family and Domestic Abuse) (Miscellaneous Amendments) Order 2023 has been published here.

What does it do?

"This Order amends Schedule 1 to the Legal Aid, Sentencing and Punishment of Offenders Act 2012 (c. 10) ("the Act") and secondary legislation under the Act.

Article 4(2) adds a new paragraph 1A to Part 1 of Schedule 1 to the Act to provide civil legal aid for proceedings for special guardianship orders. Article 4(3) amends paragraph 11 of Part 1 of Schedule 1 to the Act to provide civil legal aid for matters relating to domestic abuse protection orders introduced under Part 3 of the Domestic Abuse Act 2021 (c. 17) Article 5 makes consequential amendments to the Civil Legal Aid (Merits Criteria) Regulations 2013 (S.I. 2013/104). It also amends the current merits test for parents who are at risk of their child being removed in proceedings for a placement or adoption order to align the test with the merits test which applies to applications for civil legal aid by those parties where such an order is sought within care proceedings.

Article 6 makes consequential amendments to the Civil Legal Aid (Financial Resources and Payment for Services) Regulations 2013 (<u>S.I. 2013/480</u>). In addition, the article removes the means test eligibility requirements for parents or those with parental responsibility opposing an application for either a placement or adoption order. This aligns the approach with that taken within care proceedings.

Article 7 amends Schedule 1 to the Civil Legal Aid (Procedure) Regulations 2012 (S.I. 2012/3098) to include domestic abuse protection notices, introduced by the Domestic Abuse Act 2021, as an acceptable form of supporting evidence for applications for civil legal aid falling within paragraph 12 of Part 1 of Schedule 1. The article also amends Schedule 1 to the regulations to



enable an examination by a health professional to take place over the telephone or by video conference as an alternative to examination in person for the purposes of providing a report or letter as supporting evidence of domestic abuse. In addition, this article omits the definition of "Immigration Rules" because that term is not used in Schedule 1.

Article 8 amends the Criminal Legal Aid (General) Regulations 2013 (S.I. 2013/422) to prescribe certain proceedings under the Domestic Abuse Act 2021 as "criminal proceedings" for the purposes of Part 1 of the Act."

Housing Legal Aid SI

The Civil Legal Aid (Housing and Asylum Accommodation) Order 2023 is now published here.

From the explanatory note:

"This Order amends Schedule 1 to the Legal Aid, Sentencing and Punishment of Offenders Act 2012 ("LASPO") in relation to advice and assistance related to accommodation for asylumseekers and failed asylum-seekers to reflect prospective changes to the Immigration and Asylum Act 1999.

This Order also amends Schedule 1 to LASPO to provide for advice and assistance in relation to certain housing, debt, and welfare benefits issues where someone has already been determined to be eligible for legal aid in relation to a loss of home.

The Order also amends the Civil Legal Aid (Remuneration) Regulations 2013, which provide for the payment of remuneration to the providers of civil legal services, to specify the fees for the provision of these legal services.

The Order also amends the Civil Legal Aid (Procedure) Regulations 2012, which provide for the procedure for the making and withdrawal of determinations that an individual qualifies for civil legal aid."



Exceptional Case Funding Form and Guidance

Generally we are receiving very little feedback from members about ECF cases and we would be interested to know if that is because you have given up making applications, you only make them where there is a good prospect of success or any other feedback.



IRC/DDAS Letter

We have been told that the following letter has been sent out to relevant providers.

2018 Standard Civil Contract Specification Category Specific Rules: Immigration and Asylum ("the Contract").

"Dear Provider

I am writing to you to inform you that commencing Monday 3 April 2023, all Detained Duty Advice Scheme (DDAS) surgery appointments are to be conducted face to face and in person at the Immigration Removal Centre, as set out in the Contract. Exceptions to this may be considered by the Service Development team and where approved you will be provided written confirmation of this.

All Providers should confirm their receipt and acknowledgement of this information by responding to this letter by email to Nikki.Daniels@justice.gov.uk by **5pm Monday 27 February 2023**."

PLP Introduces the Tracking Automated Government Register



From the Network for Justice newsletter:

The Public Law Project (PLP) has launched a database revealing details of 41 secretive algorithms used by the Government to make or inform decisions on a range of sensitive policy areas, including how people are policed, what benefits they receive, and their immigration status.

Researchers at PLP created the Tracking Automated Government (TAG) register to help increase transparency and accountability of automated decision-making systems (ADMs) used by the Government, including departments such as the Home Office, Department of Work and Pensions, Ministry of Justice, and the Ministry of Defence, and regulators including Ofqual, Police constabularies, the Metropolitan Police, and several local authorities.

The register is designed to be useful for lawyers, researchers, and journalists wanting to investigate or document the impact of ADMs, and for individuals affected by their decisions.
