# **LAPG Member Update**

Issue 5 of 2025

We are delighted to launch the 2025 Legal Aid Lawyer of the Year (LALY) awards.



This year sees the 23<sup>rd</sup> outing of these non-profit-making awards, which were founded by LAPG in 2003 to celebrate the work of social justice lawyers. **Nominations will close on 22 April 2025**. Winners in the 10 award categories will be announced to an audience of around 500 guests at a **ceremony in central London on 4 July 2025**.

Why do we organise awards for legal aid lawyers? For us, the answer is pretty obvious. Legal aid is a vital, foundational element of our society. The system doesn't operate without talented and dedicated lawyers, and for too long those lawyers and their support teams have been the only thing keeping the system going. The LALYs is our opportunity to thank all those working so hard for access to justice, and to let them know their work is recognised and appreciated. It also gives others in the sector a chance to do the same by nominating their legal aid hero(es) to tell them how much they admire their work.

The LALYs is also a fillip. We know that legal aid work can be relentless, exhausting and frustrating. We know the consequences of decades of chronic underfunding from successive governments. And sometimes we all need to get together in a show of mutual support to remind ourselves of why we keep going. The LALYs is a perfect opportunity to do just that, as put by a long-standing and

battle-hardened practitioner last year:

Thank you Team LALY for another incredible event. It has given me the lift I needed to go again for another year. And go again we will!

And we also use the LALYs to improve understanding of the power of legal aid and the positive impact that can be made when lawyers are given the tools to use the law for good. Here is a quote from a senior MOJ civil servant, who attended the 2024 LALYs whilst working on the Review of Civil Legal Aid:

It was a pleasure and a privilege to be a part of this celebration, and I know I speak for the team when I say that we left with a refreshed understanding of how important the work of legal aid lawyers is, as well as a renewed sense of motivation to improve policy in this area. I don't think I speak out of turn when I say that a new government offers us a real opportunity to effect positive change.

As well as being a truly humbling and inspiring evening, it was also a very fun one! The venue, hosting, and atmosphere were all wonderful and we enjoyed the opportunity to mingle outside the confines of MS teams and meet some of the fantastic finalists. Who would have thought the LAPG could throw such a great party!

Well we're not sure about that last bit, but the rest of the quote speaks volumes about the importance of the LALYs as a way of showing those from outside the sector why we all fight so hard for legal aid.



And then there are the legal aid lawyers-to-be, who are inspired to take up the fight, and we all know important it is to encourage the next generation of social justice warriors:

As an aspiring barrister, the ceremony was incredibly inspirational. It was a powerful reminder of why I have always been drawn to the legal profession - a profession filled with individuals committed to fighting for justice and fairness for those in need. Legal aid lawyers play an indispensable role in our society, ensuring that everyone has access to legal representation regardless of their circumstances. Their relentless pursuit of justice is something I not only admire but strive to emulate in my future career.

On Friday night, I got to spend my evening hanging out with the beating heart of the legal profession, at the Legal Aid Lawyer of the Year Awards (affectionately known as the LALYS).
