# Frontier Economics interim report on the sustainability of civil legal aid

The Law Society has commissioned Frontier Economics to conduct an in-depth study to help the government understand the financial realities facing civil legal aid providers. The initial stage has focused on housing and Frontier has published an interim report based on data and interviews with around 30 providers. The research has been designed to feed into the MoJ Review of Civil Legal Aid and is complementary to the <u>research</u> <u>recently published from PA Consulting</u>.

Key findings from the report include:

- the majority of providers the research engaged with are loss-making. However, after adjusting for the recovery of interpartes costs, all providers are found to be loss-making
- the average fee earner is only able to recover around half of the full costs of providing housing legal aid
- providers rely on cross-subsidisation to sustain their legal aid housing work
- losses are largely created by low incomes and high cost burdens
- it's increasingly difficult to recruit and retain talent, and housing providers are exiting the market

Frontier is continuing its work and will be looking at other areas such as family legal aid, so please spread the word and encourage other providers <u>to</u> <u>sign up to be involved in the research</u>. The final report will be published end of March/beginning April.

# National Audit Office report on the Government's management of legal aid

The NAO is highly critical of the Government's management of legal aid in a report just published. It concludes that the Ministry of Justice (MoJ) does not know whether everyone eligible for legal



aid can access it, and that the Government must to more to ensure the sustainability of the market.

They say that the MoJ should work with providers on fee levels (which have not seen a rise for the last 28 years), suggesting it could liaise with practitioners to understand the profitability of legal aid work and market sustainability. It is a depressing, whilst unsurprising read, which does little to reassure those working in the sector that the MoJ understand the scale of the issues. However it is encouraging that further, independent research has been published to add weight to the argument that the MoJ must take significant steps to improve the legal aid scheme.

If you don't have the time or headspace to read the full report, we thought we would set out the NAO's damning conclusions here for you to savour over your afternoon cuppa:

MoJ has succeeded in its objective of significantly reducing spending on legal aid, which has fallen by more than a quarter in the last decade in real terms. Since we last reported, MoJ has done some work to better understand the impact of its reforms and is aware of several areas where changes may have shifted costs elsewhere within government. But it still lacks an understanding of the scale of these costs and so cannot demonstrate how much its reforms represent a spending reduction for the public purse overall.

Meanwhile, stakeholders have continued to raise concerns about the reforms' detrimental impact on the efficiency of the wider justice system, including the removal of early advice, and the increase in people representing themselves in courts. The increase in selfrepresentation in family courts is largely due to MoJ's failure to divert people to mediation as planned, which has undermined its objective of reducing unnecessary litigation. MoJ must now build its evidence base on the costs and benefits of providing legal aid at different stages to ensure that it is achieving value for money from its choices.

MoJ has set providing swift access to justice as one of its primary objectives. Theoretical eligibility for legal aid is not enough to achieve this objective if there are an insufficient number of providers willing or able to provide it. MoJ must ensure that access to legal aid, a core element of access to justice, is supported by a sustainable and resilient legal aid market, where capacity meets demand. It is concerning that MoJ continues to lack an understanding of whether those eligible for legal aid can access it, particularly given available data, which suggest that access to legal aid may be worsening. Also concerning is its reactive approach to market sustainability issues. MoJ must take a more proactive approach and routinely seek early identification of emerging market sustainability issues, to ensure legal aid is available to all those who are eligible. Until then, it cannot demonstrate that it is meeting its core objectives and so securing value for money.

## <u>Review of Civil Legal Aid – Call for Evidence</u> <u>deadline 21 Feb 2024</u>

Comprised of 18(ish) questions, this is your opportunity to feed in on the issues that matter most to you, your practice and your clients. You don't need to answer all the questions, but practitioners in particular will be interested in questions about their area of law, what it is like on the ground in your locality, fees (yes, they want to know if the fees are adequate) and the use of tech and remote service provision.

### <u>Updated Immigration providers south west</u> <u>support directory</u>

On 14 February the LAA published <u>the latest</u> <u>version of this directory</u>, which has been put in place due to a chronic shortage of immigration and asylum providers in the region.

We have significant concerns about the use of a remote service directory, particularly for such a vulnerable client group, and have raised these concerns as part of our response to the Review of Civil Legal Aid. Apart from the difficulties faced by vulnerable clients in accessing and using remote services, we also expect more direct action from the MoJ to ensure that providers are incentivised to set up and maintain services in all areas of England and Wales. Public Law Project has also carried out research to determine the efficacy of this particular scheme, which has thrown up considerable concern that it is failing to help clients in the south west to access legal support.
