## **Civil Legal Aid News**

<u>Civil Legal Aid tender: additional work or first time bidders: deadline 5pm on 31 March 2023</u>

This tender, which enables new providers to bid for a 2018 Standard Civil Contract and existing providers to take on additional categories of work or work in a new area, was launched by the LAA on 7 March 2023. Tenders must be submitted using the <a href="LAA's eTendering system">LAA's eTendering system</a> by 5pm on 31 March 2023.

This is just a reminder to keep an eye on the <u>tenders page</u> for any updates if you are bidding for additional work or are an organisation bidding for a first contract.

We have written to the MoJ to raise serious concerns about the likely impact of very short tender and verification timelines set by the LAA. Here is an extract from the letter sent to the MOJ's Civil Legal Aid Policy team and copied to the LAA.

"In brief, the central issue is the very short timetable for submission of tenders (31 March) and then submission of verification information (10 May - just 12 days after bidders receive notification of the outcome of their tender). This timetable creates a significant risk that both existing and potential new providers will not submit tenders because they are unable to complete processes within the timeframe allowed by the LAA. I do not know if the LAA has spoken to or checked standard response times of external bodies, but there are concerns about whether providers will be able to obtain SQM or Lexcel accreditation, or any of the panel memberships, required to submit a compliant bid within the timescales provided. There are also very practical issues to consider in relation to recruiting staff, ensuring supervisors are in place, negotiating leases and support contracts (IT services, insurance) etc. These processes all take time and the LAA has no control over them. They also all involve expenditure that providers quite reasonably do not wish to incur months before a contract commences and they can start to deliver services and thereby earn the income required to cover their costs. There is already a significant delay in-built in the legal aid scheme between commencing work and recovering income.



raised at the 8 March CCCG meeting] that the IFA gives them the discretion to accept verification information after the deadline. However most bidders will, auite sensibly, make decisions based on the stated deadline and will not make significant and potentially costly business planning decision on the basis of what the LAA may allow after the 10 May. The LAA also seems to imply that as knowledge of this tender has been in the public domain since November 2022 organisations have had time to commence processes. However this fails to understand the realities of setting up, expanding or running a legal practice, and the time, resource and cost implications of preparing for and submitting a legal aid tender. As noted above, apart from the costs incurred in setting up an office/team/department, it also makes no sense from a business planning perspective to do so well in advance of a tender exercise on the basis that the LAA has made an announcement. In this case, if providers has started to act in November when the announcement was made, they would be incurring significant cost for a contract starting almost a year hence. How can they afford to do that? And how can they assume costs and risk on the basis that the LAA may accept verification information after the deadline?

The LAA has stated [in a written response to issues

I have been contacted directly by a number of existing and potential providers to express their concern (indeed dismay) about the timetable. Some of these potential bidders have concluded that they cannot now submit a tender due to the timetable. Here are excerpts from some of the emails I have received since the announcement:

- 'I was shocked by the timetable which seems to me to be wholly unrealistic and unfair if they are genuinely interested in new applications. I was planning to apply but will not be able to do so if this timetable remains. There is absolutely no way I could meet the deadlines. I really do not understand the timetable at all.'
- 'The current tender deadline is ridiculous. 10
  May for verification is hugely problematic –
  certainly impossible for Lexcel. 20 July is more
  achievable for Lexcel.'
- 'We want to bid for family but need time to recruit a supervisor and get staff through panel membership which we can't do until we know we'd have a contract.'
- From a consultant who assists with tenders: '4
   of my clients now also worried about getting the
   SQM in time as we'd previously agreed a
   different timeline with Recognising Excellence -

- who I'm guessing are also shocked by this timeline.'
- 'The time table is far too tight for those of us with contracts who might want to think about bidding for a new contract in a new procurement area. Or a new area of law. We are thinking about opening an office in Manchester but this timetable gives us no time to plan that or consult with the other partners. For realistic business planning 8 weeks should be the minimum time ideally 12.'

If these are some of the emails I have received, there will be many, many more providers who are concerned by, if not now completely dissuaded by, the LAA's timetable."

We wrote to the MOJ on 10 March setting out these concerns and are currently awaiting a response.

## Remember to sign your extension letter: deadline is 9am on 28 April 2023

The LAA has been emailing all holders of the 2018 Standard Civil Contract with offers to further extend contracts to 31 August 2024. Providers must confirm by email whether they wish to accept the further extension by the deadline of 9am on Friday 28 April. The email included an attachment called the Extension Response Form, which must be completed and returned to the LAA by the deadline using the email address:

Where offers are accepted, new schedules run from 1 September 2023 until 31 August 2024. Details are here.

#### How many providers per procurement area?

Representative bodies meet with the LAA quarterly to discuss civil legal aid at the Civil Contracts Consultative Group meetings. At the latest meeting on 8 March 2023 a question was asked about the minimum number of providers the LAA thinks is required in each procurement area to maintain what it calls 'capacity'. While family has always been higher than other areas because of potential conflicts and the number of possible parties, we wanted to know why the LAA believes the minimum number of providers needed in categories such as housing is only one per procurement area.

In response the LAA set out the position determined through the 2010 Civil Contract tender process and referred CCCG attendees to the <u>information now held on the national</u> Archives website.

A rep body member followed this up with us.

"This is interesting. The last stated official position a) predates LAA, b) predates LASPO, and c) was a minimum of <u>three providers</u> per procurement area in the larger categories (para. 4.26).

[However, just last month LAA wrote to me that] "the LAA considers the minimum capacity requirement to deliver housing and debt work in a procurement area to be <u>a single provider</u>".

When did they move from the former to the latter and who was informed?"

So, LAPG members, can you recall what information you have seen and can you point to evidence (either recently or many years ago) as to the minimum service level that is deemed acceptable by the MoJ and the LAA? Please email policy@lapg.co.uk

Why is this important? The question of minimum service levels is central to the issue of client access and provider sustainability. The LAA's 'capacity review' process does not attempt to gauge the level of client need in a particular locality, and doesn't appear to assess the capacity of providers to meet need. This is turn feeds into wider policy within the MOJ, and even influences ministerial understanding as it is reflected in responses to questions parliamentary and Demonstrating that the MOJ's approach to assessing and setting minimum service levels needs to improve will be a crucial element of the Review of Civil Legal Aid.

## The Law Society JR on Criminal Legal Aid

The last update from The Law Society remains <u>the</u> one on 1<sup>st</sup> March but there is <u>an interesting</u> report here from Raab's evidence to the Lords Constitution Committee on the same day. It may



make your blood boil to read the summary. For example:

"He said that he has set the foundations for a sustainable criminal legal aid profession, having followed all the recommendations set out in the Independent Review of Criminal Legal Aid.

This is despite the fact the government has not met the review's recommendation of a minimum 15% increase in solicitors' rates."

### **IT** issues

We have received an email from Alice Mutasa, The Law Society's Policy Adviser on criminal legal aid.

"We are working on a letter to Raab about the LAA's IT systems. We want to pull together all the various things we know about where it is proving problematic, including the means test timetable, our request for changes to the bail to return payments, various other changes we have asked for where tech challenges have been cited as a reason for not doing something, and any evidence of practical problems such as the system falling over.

I would be really grateful if you could send me anything that comes to mind where we've requested a change and the LAA has cited IT difficulties getting in the way. Also of course all of the things that don't work properly and create additional work for you."

## **Guidance on CWA submissions**

Guidance was published on 9 March about <u>CWA</u> submissions here.



The guidance covers how CWA works online: how to claim, bulkloading, outcomes, new matter starts and guidance. There is now an updated version of Provider Bulkload Spreadsheet. This version (1.31) adds two new columns which allows providers to claim work under changes from the new Nationality and Borders Act.

## **Legal Aid Agency online training**

There are a lot of free webinars on the <u>LAA</u> <u>training and support website here</u>.

The website is very clear so it would not take long to look to see if anything is of interest. There are live training events that can be booked on Eventbrite and a selection of recorded webinars.

## Consultation on revising the 'Help with Fees' remission scheme

This consultation proposes a series of reforms to make the Help with Fees scheme more generous, target financial assistance at those most in need, whilst providing value for money for the taxpayer.

The key changes are to:

Raise the income thresholds for determining eligibility

Revising the 'Help with Fees' remission scheme

- Revise the policy for calculating when and how partial fee remission applies
- Increase the capital threshold age cap
- o Increase the lower capital threshold for determining eligibility
- Simplify the capital test

The consultation is here and closes at 11.59pm on 30 May 2023.
