### Further tender opportunity for the 2024 Standard Civil Contract

Some welcome news this week that the LAA has decided to run a further tender round for the 2024 Standard Civil Contract. The tender opens on 18 March and closes at 5pm on 22 April 2024. This gives those who were unsuccessful in securing a contract through the September 2023 tender process another bite at the cherry. The tender process is also open to new providers.

Bids can be submitted in all procurement areas across all civil legal aid categories, including 7 HLPAS schemes.

While the intention is that successful bidders will commence work on 1 September 2024 (the start date for the 2024 Standard Civil Contract) the LAA has noted that it cannot guarantee that start date through this process because of the need to complete verification.

### **Review of Civil Legal Aid - LAPG Call for Evidence response**

We submitted our response to the RoCLA Call for Evidence on Wednesday. It's a bit of a doozy at 105 pages long so we're just in the process of putting together an executive summary of all the recommendations we have made to improve the legal aid scheme. You won't be surprised to hear that we mentioned fees over 300 times in our response. It is deeply depressing that we had to reference the 1994 and 1996 remuneration regulations when explaining the hideously adverse impact of fees that have only gone backwards over the last three decades.

We are incredibly grateful for the contributions we received from so many members. In the end over 100 organisations and individuals provided us with direct evidence, feedback on our drafts and/or copies of their responses. It is incredibly heartening that once again so many busy practitioners stepped up to support our policy work and demonstrate their unwavering commitment to access to justice.

While the LAPG office breathed a collective sigh of relief once we hit send on our response, the work doesn't end there. The MoJ is now considering all the evidence submitted and we know that they received some excellent responses from Resolution, The Law Society, ILPA, Public Law Project, Law Centres Network and many other membership and representative bodies. We also know that a number of provider organisations directly submitted their own responses. And of course the call for evidence is just one element of RoCLA, with work streams looking at economic viability, user journeys, the available data and research and potential solutions from overseas jurisdictions. There can be no doubt that by the end of this process the MoJ will have collated the most comprehensive set of data and evidence about the current civil legal aid scheme in over a decade. What they do with it is the next big

question. And can they build a persuasive case to obtain additional funding from Treasury?

There are many big questions left to answer by the MoJ, but one of them will not be whether they have received sufficient input from legal aid practitioners to enable them to understand why the scheme is on its knees. So we await the 'next steps' report from the MoJ and, subject to the timing of the general election, a consultation on policy recommendations in the summer.

### **Frontier Economics interim report on the sustainability of civil legal aid**

Many Members will know that The Law Society commissioned Frontier Economics to conduct an in-depth study about the financial realities facing civil legal aid providers. The initial stage has focused on housing providers and [\*\*Frontier has published an interim report based on data and interviews with around 30 providers.\*\*](#)

Frontier is continuing its work over the coming months and will be looking at other areas such as family legal aid, so please spread the word and encourage other providers [\*\*to sign up to be involved in the research.\*\*](#) The final report will be published end of March/beginning April with a view to influencing the MoJ's policy recommendations arising out of RoCLA so please do get involved if you can.

### **Updated Immigration providers south west support directory**

This was updated once again on 21 February with the LAA publishing [\*\*the latest version of this directory here.\*\*](#) Members will recall that this mechanism has been put in place due to a chronic shortage of immigration and asylum providers in the region. The very existence of this directory is yet more proof of the parlous state of legal aid provision across England and Wales, as we and many other groups set out in our Call for Evidence responses.

As noted in our previous Update, we have significant concerns about the use of a remote service directory, particularly for such a vulnerable client group. Apart from the difficulties faced by vulnerable clients in accessing and using remote services, we also expect more direct action from the MoJ to ensure that providers are incentivised to set up and maintain services in all areas of England and Wales. Public Law Project has also

carried out research to determine the efficacy of this particular scheme, which has thrown up considerable concern that it is failing to help clients in the south west to access legal support.
