Legal Aid Practitioners Group launches its 18th Legal Aid Lawyer of the Year awards today.

Nomination period ends 3 April; and this year sees the introduction of three new award categories:

- Regional Legal Aid Firm/Not-for-profit agency**
- Legal Aid Team**
- Mental Capacity Law**

Winners to be announced at awards at ceremony on 7 July in central London.

The 2020 Legal Aid Lawyer of the Year (LALY) awards are launched today (Monday 17 February), with awards in 12 categories to be won (see full list, below).

LAPG CEO Chris Minnoch says:

"Given the current political climate, it is hard for those of us who care about access to justice to find much to cheer about - which is why these awards are now more important than ever. The LALYs are the one time in the year when legal aid lawyers come together as one, to celebrate the work we do to protect the rights and improve the lives of ordinary people and their families. Without us, many of the most vulnerable in our society would have no chance of making their voices heard."

The LALY awards are non-profit-making, and only made possible thanks to our sponsors (see below).

For the fifth year, LALY20 will be crowdfunding sponsorship for its important Legal Aid Newcomer award, which celebrates the inspiring work of newer entrants. Crowdfunding donations start from £10; all donors are recognised as Friends of LALY20, and will have their name published in the ceremony programme.
