## LAPG HPCDS consultation response and the Early Legal Advice Pilot

On 20 January 2022 we published our response to this interesting consultation on the future of Housing Possession Court Duty Schemes. We think it is interesting because it shows genuine intent from the MOJ to improve the sustainability of HPCDS schemes. However, as set out in our (holiseed) > keesse >

response, we have a number of serious reservations about the proposed model and about the MOJ's unwillingness to address the broader, systemic issues undermining client access and the viability of providers. We make the point that without addressing these wider issues, the relatively modest proposals within this consultation will do little to ensure HPCDS schemes are more effective or more sustainable.

We anticipate a great deal of ongoing dialogue with the MOJ about future arrangements for HPCDS services and how to improve the sustainability of legal aid providers more generally. This consultation must also be viewed in conjunction with the MOJ's plans to pilot and assess the effectiveness of early legal advice for linked social welfare law problems. On 19 January 2022 the MOJ laid a new statutory instrument before parliament to enable the pilot: The Early Legal Advice Pilot Scheme Order 2022. The instrument has not yet been considered by the Joint Committee on Statutory Instruments but it is anticipated that this will happen in February. Parliamentary Under-Secretary of State with responsibility for legal aid, Lord Wolfson, has described the pilot thus:

The Early Legal Advice Pilot is one of several pilots which the Government committed to in its Legal Support Action Plan (2019), which set out a range of actions to be taken forward to ensure that legal aid continues to be available and effective for the most vulnerable. The pilot is designed to test the expansion of legal aid to an area of social welfare, demonstrate the possible benefits of advice in encouraging early resolution, and quantify the downstream benefits of early resolution to Government, individuals and other stakeholders such as local authorities. These objectives were developed in response to the Post-Implementation Review of the Legal Aid, Sentencing and Punishment of Offenders Act 2012 ("LASPO").

In a nutshell, the SI amends LASPO to enable a small cohort of providers (in this case in Manchester and Middlesbrough) to deliver a fixed amount of advice to housing clients on debt and welfare benefits issues (bringing these issues back into scope in very limited circumstances). The advice will also be non-means and non-merits tested for the purposes of the pilot. The stated aim of the pilot is to test whether early provision of legally aided advice in these areas of law helps to encourage early resolution of certain housing, welfare benefit and debt issues (reducing homelessness long-term).

We have already raised numerous concerns with MOJ about the model, the remuneration and the location of the pilot, but not all of these concerns have been taken on board. We are seeking further clarification from the MOJ about how the pilot will work in practice and how it will be evaluated and will update you as soon as we can.

## Criminal Legal Aid Review: APPG meeting and Law Society webinars

#### **APPG on Legal Aid meeting**

Following the publication of <u>Sir Christopher</u> <u>Bellamy's Criminal Legal Aid Independent Review</u> <u>report</u> in December 2021, the government has committed to responding by the end of March 2022. The report and recommendations have generated a great deal of debate across the sector about what might happen next for criminal legal aid. The All-Party Parliamentary Group on Legal Aid will be hosting a meeting on 9 February 2022 to consider the CLAIR report. The Minister with responsibility for criminal legal aid, James Cartlidge MP, will be speaking along with representatives from a range of practitioner groups.

# LAA opens tender for contract to administer the SQM

From the LAA on 27 January 2022:

A tender opens on 27 January 2022 to deliver auditing services for the Specialist Quality Mark.

The tender is open to any interested party that can meet the minimum tender requirements. We are seeking to award one contract for the delivery of this work across England and Wales.

We are also updating the SQM standard and SQM guidance. These changes will come into effect on 1 October 2022.

#### Timescales

- tender opens on 27 January 2022
- deadline for submitting tenders is 5pm on 10 March 2022
- services under the new contract will begin on 1 October 2022



#### What is the SQM?

The SQM is the organisational quality standard owned by the LAA. It is designed to ensure providers of legal services:

- are well managed
- give good levels of client care
- deliver good quality advice through appropriate systems

It is a requirement for legal aid contract holders to hold either the SQM or the Law Society's equivalent 'Lexcel' accreditation.

## Justice First Fellowship scheme opens applications for 2023 host organisations

A very exciting announcement from our good friends at The Legal Education Foundation:

Applications are now open to organisations interested in hosting a Justice First Fellow in 2023.

Next year will see the 9th cohort of trainee solicitors take up coveted places in social justice organisations across the UK. The Legal Education Foundation are looking for 15-20 organisations to support these Fellows. Applications will be accepted for both training The Legal Education Foundation contract and SQE routes to qualification. Charitable organisations who wouldn't be eligible to host a solicitor trainee are also encouraged to get in touch with us and discuss their suitability to host in partnership with a legal advice provider who can provide the required legal supervision. This is an approach that is working well in the current cohorts of Fellows.

The JFF programme has elements which work to benefit both the host organisation and the Fellow. It consists of a grant covering training and supervision costs for the two years of a Fellow's training contract; bespoke training for Fellows and hosts including fundraising, project management and self-care; and access to an ever-growing network of JFF alumni and legal advice providers.

BBC Children in Need continue their support this year and so applications from potential hosts with a focus on child law are especially encouraged.

#### **The Human Rights Act Government consultation**

#### 16 February 2022

The Government's HRA consultation closes on 8 March. The consultation proposes major changes to the operation of the HRA and follows the Independent Human Rights Act Review (IHRAR) led by Sir Peter Gross. Public Law Project are convening a day of panels to assist organisations and individuals across civil society, Government and private bodies in Wales to consider their response. PLP's main focus is on the proposals that would affect how people can enforce their legal rights and hold public authorities to account.
