As a **Housing Solicitor**, we'll rely on you to maintain an active caseload and provide legal advice and representation to families and young people who are homeless or at risk of homelessness in Edinburgh, in partnership with CLAN. You'll also be responsible for developing housing and homelessness law for families, children and young people and devising and delivering lawyer led training for front line third sector services. Working collaboratively within the sector to directly address issues that may arise with the implementation of the 'Ending Homeless Together High Level Action Plan' will be important too, as will promoting an understanding of the legal framework and ensuring a rights based approach from the outset.
